- 1. **Contract Required**: All trainers must have a signed and current month-to-month contract paid in full before using the gym or hosting clients at the gym.
- 2. Renewal Not Guaranteed: Contract terms are month-to-month Renewal is not guaranteed.
- 3. **Waiver is Required**: Trainers and trainees must both sign a waiver and release of liability before accessing the gym or using any of the gym's facilities.
- 4. **Use of Equipment**: Trainers and trainees must keep equipment intact and shall not modify the equipment. Reconfiguring the equipment consistent with accepted usage is permissible.
- 5. **Damage to Equipment**: Trainers and trainees will be held responsible for damage to equipment, which results from willful actions, neglect or recklessness, including the cost or fees to repair or replace damaged equipment. These costs may be deducted from the Trainer's deposit.
- 6. **Appropriate Clothing**: Trainers and trainees must wear tops fully covering their chest at all times while on premises at the gym.
- 7. **Changing Room Provided**: Trainers and trainees must use the changing room provided if outfit changes are made on premises. Changing outfits in the workout area is strictly prohibited and is grounds for immediate termination of access privileges to the gym facilities.
- 8. **Shared Space**: All workout areas and equipment are shared equally between all trainers and trainees without preference or priority. Usage must be coordinated at the time of attendance.
- 9. **Injury**: Saatchi Fitness provides access to exercise equipment and is not liable for injuries to trainers or trainees through the use of such equipment. Trainers are responsible for the safety of their respective trainee(s) and trainees are prohibited from use of the gym equipment without the active supervision of a trainer having a current contract to access the facilities of Saatchi Fitness.
- 10. **Insurance**: Insurance carried by Saatchi Fitness does not cover the trainers or their trainees and trainers are advised to obtain their own liability coverage for their trainee clients. The trainers are contractors only. Saatchi Fitness does not employ the month-to-month contract trainers.
- 11. **Payments and Taxes**: Saatchi fitness does not collect payment from trainees on behalf of trainers and is not responsible for the payment of fees or dues from the trainees of any trainer having contracted with the gym. Similarly, Saatchi Fitness has no involvement whatsoever in the withholding of taxes or tax treatment of the contract trainers.
- 12. **Personal Property**: Saatchi Fitness is not responsible for the personal property of trainers or their trainees, including items brought into the gym during exercise or items left or abandoned at the gym after exercise sessions. Saatchi Fitness provides lockers via which to lock and secure personal items. Locks are not provided and are the responsibility of trainers and trainees.
- 13. **Vehicles**: Saatchi Fitness is not responsible vehicles parked on premises or the contents of those vehicles while parked in the parking lot. Trainers and trainees may use the parking lot on premises only during and immediately before and after use of the gym facilities.
